Whereas the First Party is a Private Intermediate & Degree College in the state of Telangana. And that it intends to encourage vocational training among women to help them learn skills that could be useful in advancing their career and as a tool to attain employment / self-sufficiency in life. that it recognizes that courses offered under the Second Party are useful skills to be imparted to ladies to help them in personal grooming and as a viable employment option.

And whereas, the Second Party is an established institute with operations in Hyderabad and has been in the business of training Beauticians and Fashion Designers in Junior and Degree Colleges and at its institute since 1993.
