**Subject :** Memorandum of Understanding between **Team Sambhava Foundation Reg. 1208/2019** and **Nss wing, Sarojini Naidu Vanita Maha Vidyalaya** (affiliated to Osmania Universtiy)

**Dates applicable:** From March 2020 until March 2025.

1. The purpose of this document is to describe the working model that will be established between the Team Sambhava Foundation (hereby called Team Sambhava) and the NSS Wing of Sarojini Naidu Vanita Maha Vidyalaya (hereby called VANITA).
2. An agreement between VANITA and Team Sambhava will ensure that each of them understand the missions and goals of each other's institutions and will provide resources and support to complete their SERVICE events. The SERVICE events as per the institutional needs of each of them will be considered during the course of time every academic year.
3. Team Sambhava will create opportunities through their events, for NSS students of VANITA to participate and complete 50 (Fifty) of their Service Hours (asapart of NSS curriculum).
4. Team Sambhava will ensure that all such events where VANITA students participate are conducted in a girl's facility only – eg. Government Girls School, Girls Orphanages. Typically, they will be involved in Vidya, Bodha, Spardha programs conducted by Team Sambhava in Government Schools and orphanages.
5. Team Sambhava will ensure that all such events where VANITA students participate are within the premises of Hyderabad Urban only. Team Sambhava will provide food and any other arrangements required for the NSS volunteers during such Service events.



# Memorandum of Understanding between Team Sambhava Foundation and NSS wing, Sarojini Naidu Vanita Maha Vidyalaya


6. Team Sambhava will ensure safety and security of all VANITA students during such events. VANITA will have a representative teacher or appropriate staff member or Student Leader to accompany the students for such SERVICE events.
7. At the end of each Academic year, Team Sambhava will provide a certificate to the participating NSS volunteers acknowledging and appreciating their Service Efforts.
8. In every such event, there will be a minimum of 4 and a maximum of 10 student volunteers from VANITA accompanying Team Sambhava volunteers. This is subject to change for special events on mutual understanding between Team Sambhava and VANITA.
9. VANITA will have occasional sessions / workshops where Team Sambhava volunteers will come and conduct awareness sessions for the students of VANITA. These sessions could include larger student audience than just the NSS volunteers. Example Topics for such sessions - Mock Interviews, Readiness for Corporate Jobs, Women Safety in Workplace, Entrepreneurship, Career Counselling. Team Sambhava and VANITA together will agree and conduct minimum of 6 (Six) such sessions in every academic year. The schedule for such events will be agreed upon before the events as required. All such events will be arranged in VANITA premises and the necessary arrangements within the campus will be provided by VANITA management.
10. This Memorandum of Understanding is subject to change based on request of either Team Sambhava or VANITA and requires at least 2 and maximum of 4 representatives from each organization, to discuss and approve the changes. The authorities for any such changes should include one of the signatories on this document or their nominee.



## CLAUSE 4 : RELATIONSHIP BETWEEN THE PARTIES


