 - Easy entry/exit access
 - Access to auditorium through ramp, wheel-chair and humanassistance
 - o Disabled-friendly washrooms
 - Scribe facility for individuals who require human assistance during the course of examinations in compliance with guidelines
 - Provision for guidance and counselling
 - On campus medical facility
 - Ensuring dissemination of information
